### TRANSACTION IN OWN SHARES

SSE plc (the "Company") announces that on 24 August 2017, the Company purchased (through Morgan Stanley & Co. International Plc) a total of 306,393 Ordinary Shares of nominal value £0.50 each in the capital of the Company. The purchased shares will be held as treasury shares.
